## **Regional Prevention Center**

**Prevention Specialists** provide training, technical assistance, and resources to communities.

Adanta's Regional Prevention Center provides professional assistance to the Lake Cumberland communities in the planning and implementation of activities aimed at preventing substance abuse. The Regional Prevention Center uses six major evidence-based and science-based strategies identified by the Center for Substance Abuse Prevention (CSAP). The strategies are used to design comprehensive programs aimed at specific target populations and include: information, education, alternatives, environmental strategies, community-based process and problem identification, and referral.

The Center also utilizes the Strategic Prevention Framework (SPF) endorsed by CSAP to implement substance abuse prevention. The framework outlines five steps that embody a strategic planning approach. The ultimate outcome is measurable change in substance abuse and related factors and consequences of substance abuse. A Resource Library is located in Somerset that includes a collection of print materials, videos and other prevention resources available for public use.

Other programs within Adanta's Regional Center are as follows:

**Early Intervention Program** serves youth under 21 considered high-risk for developing substance abuse problems with screening, education and referral services.

**Zero Tolerance Program** serves youth under 21 for DUI convictions with required state regulated screening, education and referral services.

**Kids Now Plus Program** serves pregnant women with prevention education about the risk to the fetus from use of alcohol, tobacco and other drugs, as well as, providing case management services in an effort to reduce barriers to having a healthy baby. Universal classes are provided for any pregnant woman and Selective and Indicated classes, for women with risk factors indicating increased risk for developing substance abuse problems.

## Case Management Services include:

- a. Outreach to pregnant women at risk for Substance Abuse (SA), Mental Health (MH) and Domestic Violence (DV) problems
- b. In-depth screening for risk, and referrals to SA, MH and DV services as indicated
- Basic case management services (referral to resources for necessities such as housing, food, childcare)

d. If indicated, case managers follow the woman through her pregnancy, using Motivational Interviewing and incentives to: Increase readiness to follow through on referrals to clinical services, and/or to reduce alcohol, tobacco and other drug use.

#### FREE CORE ADULT EDUCATION SERVICES

- Adult Literacy—Instruction for adults who have little or no skills in reading, writing, speaking, and math/problem solving.
- Adult Basic Education—Instruction for adults who lack competence in reading, writing, speaking, math/problem solving at a level to function in society and the workplace.
- Adult Secondary Education/GED® Preparation—Instruction for adults who have some literacy skills and can function in everyday life, but who are not proficient in reading, writing, speaking, and math/problem solving or instruction for those who do not have a high school diploma.
- **Corrections Education**—Instruction for adult criminal offenders. Instruction may consist of adult literacy, adult basic education, adult secondary education, GED® preparation, English-as-a-Second Language.
- Family Literacy—Opportunities for parents and their children to learn together.
- **English-as-a-Second Language**—Instruction for adults who have limited English proficiency.
- English Literacy/Civics—Instruction in English literacy and civics education for immigrants and those who have limited English proficiency.
- **Workplace Education**—Instruction in soft skills such as communication, problem solving, critical thinking, or team building, and computer skills in introduction to computer literacy, word processing, spreadsheets, e-mail, and the Internet.

Substance abuse is often a factor in domestic violence relationships. While Bethany House does not provide substance abuse treatment, we work with other providers to help our clients access the services they need.

# **Operation UNITE Treatment Referral Line**

Operation UNITE provides a toll-free line for anyone seeking assistance with drug addiction. The number is 1-866-90-UNITE (1-866-908-6483).

This line is available during normal business hours, 8 a.m. to 5 p.m., Monday through Friday.

Individuals seeking treatment, as well as family members in need of support, can call the referral line to learn about available treatment programs in the region and the appropriate steps they must take in order to enter a program that will meet their needs. All calls are kept confidential.

Through UNITE's treatment initiative, individuals seeking help may be directed to short- or long-term treatment programs, Drug Court, or After-Care support programs. Low-income

individuals living in Kentucky's Fifth Congressional District may also qualify for a Voucher Program that will help cover the costs of residential treatment for drug-related addictions.

## **Pulaski County Health Department**

The Pulaski County Health Department offers the Cooper/Clayton Smoking Cessation program. This is a 12-week program that emphasizes the use of nicotine replacement products. It meets once a week for an hour. Classes start in January, February, April, May, September, and October. ## **Law Enforcement**

Operation UNITE, in conjunction with Appalachia HIDTA (High Intensity Drug Trafficking Area), provides a toll-free line to report suspicious activity. The number is: 1-866-424-4382. This line is manned from 8:30 a.m. to 4 p.m., Monday through Friday. During all other times callers will be able to leave confidential tip information on an answering machine.

Callers to the Drug Tip Line will be asked to provide:

- County, city or other jurisdiction in which the suspicious activity is taking place.
- Road name or highway number where the activity is occurring.
- Name(s) of the people involved in the activity.
- A description of the activity that is taking place.
- Time of day the activity was observed.
- · What types of drugs are involved.
- A description of any vehicles involved, including license tag number.
- Whether there are children in the home or around the activity.
- If there are any guns or other weapons at that location.

UNITE and Appalachia HIDTA do not keep records of actual telephone conversations. Messages left on the answering machine are deleted once tip information is logged.

Immediately after a drug tip is received, the information is entered into a computer database and is assigned a number. If any information was written down those documents are shredded. The database is then available through a secure on-line connection to UNITE and HIDTA detectives. You may choose to provide your name and phone number if you would like detectives to contact you for additional information.

Every call to the Drug Tip Line is investigated, but it probably won't be the same day. If you believe the behavior you are reporting poses a threat of imminent harm to others, you should call 9-1-1. Often your tip may provide the necessary information to obtain search

warrants or move forward on a case. No piece of information is too small.

Depending upon what detectives discover during their investigation, it may take months before the public will see any results. This is especially true if confidential informants are used to help make the case. Because an informant may be working several locations at the same time, immediate action could jeopardize other cases. Also, if an arrest is made immediately following an undercover drug purchase it would not be difficult for the suspect to identify who was working with police, thereby putting the informant's safety at risk.

## **Kentucky Court of the Justice**

## **Court Designated Worker Program - 677-4093**

To reduce delinquency among Kentucky's youth through a collaboration of statewide precourt services and programs that promote education and accountability.

The court designated worker and the young person define the terms of the diversion through a collaborative process. This takes place in a formal conference that parents are requested to attend. Diversion agreements consist of conditions that relate to the alleged public or status offense and often include one or more of the following:

- Restitution
- Community Service
- Service Learning Projects
- Curfew
- Educational Seminar Attendance
- Referral to Counseling
- Drug/Alcohol Assessments/Mental Health Assessments

The diversion process is designed to educate, instill a sense of accountability, and deter young people from getting into further trouble. If a young person successfully completes the agreement, the case is dismissed. If he or she fails to comply with the conditions of the diversion agreement, the case will be set for formal proceedings.

## Casey's Law

#### What is Casey's Law?

The Matthew Casey Wethington Act for Substance Abuse Intervention is named for Matthew Casey Wethington, who died in 2002 from a heroin overdose at the age of 23. Casey was an energetic young man who enjoyed life until it was "taken" by drugs. Casey never intended to become addicted to drugs when he used the first time. What he did not realize was that his using would progress from abusing to dependence and then to the disease of addiction. Although his parents tried to get him help, there was no law that could force someone into treatment because he was an adult. After Casey's death his parents lobbied for a change. "Casey's Law" passed on April 9, 2004, and took effect July 13, 2004.

#### What does this law provide?

The act provides a means of intervening with someone who is unable to recognize his or her need for treatment due to their impairment. This law will allow parents, relatives and/or friends to petition the court for treatment on behalf of the substance abuse-impaired person.

#### Why is this law needed?

Denial and distorted thinking impedes a person's ability to make a rational decision. The "bottom" for many is death. Addiction is a progressive, life-threatening disease. The best hope of survival for a person who is substance abuse impaired is intervention. Studies show that involuntary treatment can be just as successful as voluntary treatment. Most individuals who are substance abuse-impaired receive court-ordered treatment only after they have become arrested for a crime while under the influence of a substance. Drugs and crime often go hand-in-hand because people who are substance abuse impaired are forced by their disease to resort to any means necessary to procure their drug. Court-ordered treatment can be effective regardless of who initiates it. Not all people who are substance abuse impaired are arrested or, in the event that they are, may not receive the necessary treatment.

## What is the process to use Casey's Law?

The following steps must be taken in order to involuntarily commit someone to treatment:

- Obtain a copy of the petition from the District Court clerk's office by requesting
   Form 700A the Verified Petition for Involuntary Treatment of Alcohol/Drug Abuse
   – or download this form from Operation UNITE's website –
   www.operationunite.org.
- A spouse, relative, friend or guardian of the substance abuse-impaired person completes the petition and files it with the District Court clerk.
- The court reviews the allegations in the petition and examines the petitioner under oath.

- The court determines whether there is probable cause to order treatment for the person named in the petition (the respondent).
- If probable cause is established a judge appoints an attorney to represent the respondent, order the respondent to be evaluated, and schedule a hearing within 14 days.
- The respondent is notified of the date and purpose of the hearing.
- The respondent is evaluated by two qualified health professionals, at least one of whom is a physician, to determine if the respondent could benefit from treatment.
- If the judge finds the respondent should undergo treatment, the court shall order treatment from 60 days up to 360 days, depending upon the request in the petition and the result of the evaluation. Treatment options vary depending upon each individual's circumstances and can range from detoxification to intensive treatment through recovery.

## Who pays for treatment?

As the law is currently written the petitioner is obligated to pay all costs incurred in the process as well as for the court-ordered treatment. The petitioner must sign a guaranty for payment. Low-income individuals living within the Fifth Congressional District may qualify for a UNITE treatment voucher if they acknowledge that they have a problem. ## What happens if the respondent fails to comply?

Failure to comply at anytime during the process may place the respondent in contempt of court.

#### What is UNITE's role?

Operation UNITE is helping to raise awareness of this law's existence by distributing pamphlets and educating court staff. It is UNITE's opinion that those with a substance abuse problem often need treatment, but are unwilling to seek assistance. This law has the potential to save lives by enabling family and friends to look out for a person's best interest.

## **Youth Programs**

The cornerstone of UNITE's efforts are its programs focused on youth. UNITE's programs seek to empower youth to remain free from alcohol, tobacco and other drugs and to become leaders within their school and community. This is achieved by developing drug prevention, intervention and leadership programs and by providing drug-free, youth-targeted activities.

#### **Camp UNITE 2010**

- Free 4-day/3-night adventure camp for youth entering grades 7-9.
- Fourth annual camp scheduled for the University of the Cumberlands campus in Williamsburg, KY, July 27-30.
- Transportation to camp will be provided.
- Camp activities are designed to develop leadership and communication skills, promote teamwork and problem solving, instill confidence and trust, and let youth know they do not have to face difficult situations on their own.
- Activities include competitive events, swimming, outrageous games, live youth concert, motivational speakers, visit to the Hal Rogers Water Park, and more.

#### The First Tee

- The World Golf Foundation initiative to impact the lives of young people of all backgrounds by providing learning facilities and educational programs that promote character development and life-enhancing values through the game of golf.
- Focuses on nine core components: honesty, integrity, sportsmanship, respect, confidence, responsibility, perseverance, courtesy and judgment.

## **Hooked On Fishing-Not On Drugs® (HOFNOD)**

- This Flagship program of the national Future Fisherman Foundation is an on-going program that provides caring adults in a mentoring relationship, giving youth a fun alternative to using drugs.
- Designed for ages 5 and up, curriculum includes drug education while teaching youth fishing and conservation skills.
- UNITE provides free training for adult facilitators and assists coalitions with start-up costs through local coalitions.

#### **UNITE Service Corps**

- Provided in conjunction with the AmeriCorps program.
- Members provide math tutoring services, instruction in the "Too Goods For Drugs" curriculum and work with anti-drug school UNITE Clubs.

#### **National Archery in the Schools (NASP)**

- Provided in partnership with the Kentucky Department of Fish & Wildlife Resources.
- Designed to teach students in grades 4-12 responsibility, discipline and respect while they learn basic archery skills.
- A physical education and cross-curriculum in-school course and after-school club designed to engage students who may not take part in regular school sports activities.
- Educators report the program is extremely successful in engaging all students regardless of their physical condition or ability, and results in improved behavior and attendance.
- UNITE provides funds through coalitions for start-up equipment for clubs.

#### **Shoot Hoops Not Drugs**

- A series of free, one-day regional basketball camps for school-aged youth conducted by former University of Kentucky star Jeff Sheppard.
- Provides an opportunity to interact with positive role models, receive positive antidrug and self-esteem messages in conjunction with basic basketball skills instruction.
- A brief education program on the signs, symptoms and dangers of drugs will be provided to parents/guardians.
- Participants receive a free basketball, T-shirt, drinks and hotdogs.

## **Anti-Drug Sporting Events/Leagues**

- Communities have structured a wide variety of sporting programs including basketball, football (UNITE Bowl), soccer and swimming – around an anti-drug theme.
- Civic, business and faith-based groups partner to promote and conduct these programs, which include anti-drug activities and prevention messages throughout the event.

## **Thespian Programs**

- School- or coalition-based drug prevention programs that use acting and theater to
  educate the public about the danger of drugs and about positive life choices and/or
  developing self-esteem.
- Drama groups implement program in two phases: First students write or select an anti-drug script using researched information, the cast participants and practice roles. The second phase is the performance, where critical information is passed along to the audience.

### **UNITE Clubs**

- Anti-drug school clubs targeting grades 4-12 that operate like any other club recognized by schools.
- UNITE Clubs help youth develop healthy attitudes and behaviors by learning and practicing life skills, enhancing academic performance, connecting peers, adults, communities, and learning through service.
- Youth are involved in developing and conducting activities designed to help make their schools and communities healthy and drug-free as well as mentoring younger students.

## **Youth Summits**

- A regional gathering of elementary, middle and high school student leaders to encourage and motivate their peers to remain committed to living a drug-free life.
- Educational sessions provided for both youth and adult leaders.
- Awards program celebrates previous leadership accomplishments of UNITE Clubs within their school and community.

## **Treatment & After-Care Programs**

After-care is a term used to collectively refer to all support programs once a person leaves a treatment facility. Individual programs will vary in focus, but generally involve meeting in small groups to encourage and support individuals in their quest for help. This is accomplished by establishing mentoring relationships, encouraging continued education or job training assistance, providing transportation assistance, conducting fun activities, and opening up non-judgmental lines of communication. Rebuilding a person's self-esteem and feeling of self-worth helps recovering addicts realize they do have control over their lives.

## **Chad's Hope Teen Challenge Center**

- A residential recovery center for adult males located in Clay County.
- Teen Challenge exists to provide youth, adults and families with an effective and comprehensive Christian faith-based solution to life-controlling drug and alcohol problems in order to become productive members of society.

#### **Drug Court**

- Through a partnership with the Kentucky Administrative Office of the Courts,
   Juvenile and Adult Drug Courts offer non-violent drug offenders an opportunity at rehabilitation through an intensive supervision and treatment program.
- During this multi-phase program -- which takes 1-2 years to complete under the direction of a volunteer judge -- participants receive employment and educational training, drug counseling, and family support.

#### **Support Groups**

- UNITE maintains a comprehensive listing of active support groups serving each county in the Fifth Congressional District.
- UNITE coalitions actively support a number of providers, including:
  - oAl-Anon/Alateen -- Offering hope and help to families and friends of alcoholics. Members share their own experience, strength and hope with each other in weekly meetings. Through a 12-Step program members find a "power greater than ourselves" to help solve problems and find serenity
  - o Celebrate Recovery -- Celebrate Recovery is a ministry-based on biblical principles. The program's focus is to fellowship and celebrate God's healing power in lives through "8 Recovery Principles" and a Christ-centered 12-Step Program. Celebrate Recovery provides a safe place for individuals to begin their journey of breaking out from their bondage and into God's grace by helping them start dealing with their life's hurts, hang-ups and habits.
  - o Hebron Fellowship -- Hebron Fellowship groups provide an after-care ministry within local communities for people with chemical dependency who complete a free 10-week program provided by Hebron Colony Ministries in North Carolina. Participants provide support to students who are returning home and face the very hard task of living a Christian life in the same area from which they came. Support is based upon "10 Principles for Living."
  - o Lifeline of Eastern Kentucky -- A ministry of Teen Challenge International, Lifeline of Eastern Kentucky offers non-residential ministry groups designed to reach out to people facing everyday challenges of life that can become overwhelming, such as addiction to alcohol and other drugs, and to provide support for their

- families by implementing the five components of recovery decision, positive peer choice, accountability, boundaries and consistency.
- ONarcotics Anonymous -- Narcotics Anonymous is an international, community-based association of recovering drug addicts who meet regularly in groups to help each other stay clean by sharing successes and challenges in overcoming active addiction and living drug-free productive lives through the application of principles contained within the Twelve Steps.
- o Reformers Unanimous -- Reformers Unanimous International is a Christ-centered addictions program using weekly addictions classes. Reformers Unanimous is headquartered under the authority of the North Love Baptist Church in Rockford, Illinois. Program is centered on "7 Philosophies of Addiction."

#### **Treatment Referral Line**

- A toll-free line 1-866-90-UNITE (1-866-908-6483) -- for anyone seeking assistance with a drug addiction. All calls are kept confidential.
- Individuals and family members seeking treatment or support can learn about programs that are available within our region.

#### **Treatment Vouchers**

- Low-income residents of the Fifth Congressional District with a substance abuse problem may receive financial assistance for treatment.
- UNITE will pay a provider up to \$3,000 for short-term (up to 89 days) or up to \$5,000 long-term (90 or more days) residential treatments for adults and juveniles.
- Detoxification treatments are not covered.
- Voucher recipients generally receive faster placement due to contracts UNITE has with treatment facilities.

## WestCare Hal Rogers Appalachian Recovery Center

- A residential recovery center for adult males located in Pike County.
- Individuals receive counseling using the 12-step process, relapse prevention education, anger management, parenting and cognitive behavioral therapy classes.

- Training time 3 hours for professional first responder groups such as local police, fire firefighters, and emergency medical technicians.

- Training time 1 hour

  - Explanation of marketing of these drugs to youth
  - ODetailed description of each drug, it's chemical components and reaction with the human body when used both legally and illegally
  - What communities can do to protect themselves against abuse by addressing risk and resiliency factors
  - Where to get help? Out-patient treatment; in-patient treatment; counseling;
     support groups; UNITE Treatment Referral Line

#### **Raising Healthy Kids**

- Training time for parents varies
- A prevention and intervention program of Focus on the Family for parents and caregivers to help strengthen relationships and parenting skills.
- UNITE staff will provide training to groups or facilitators.
- Program goals include:
  - o Learn how to initiate meaningful family conversations to bring stability and connectedness in order to reduce high-risk behaviors.
  - OUnderstand key factors that may lead to risky behavior.
  - $\circ\operatorname{Examine}$  "conflicting messages" we may be sending to our children.
  - Asses your child's ability to express love.
  - OBetter understand your family and document your growing relationship with your children.

## "Too Good For Drugs" curriculum

- A 10-lesson, school-based drug, alcohol and tobacco prevention program designed for use by kindergarten through 12<sup>th</sup> grade students.
- The program provides education in social and emotional competencies and reduces risk factors while building protective factors that affect students in that particular age group.
- Instructional strategies include role-plays, modeling, practicing, reinforcing, providing feedback, and promoting the generalization of skills to other contexts—all of which promote cooperative learning and skill building.
